- If <u>you are NOT</u> attending the Annual Meeting, you must deliver the YELLOW proxy page completed, with voting on Budget and Board member election already marked to Dawn Kerns, President (unit 125D), or to Nomination Chairman Brenda Owens at 117A.
- IMPORTANT **DO NOT MAIL your proxy** at this late date as the mail is slow these days!
- If you did not receive your packet, please contact Brenda Owens at 509-952-3629 for a Ballot or Proxy if you do not have one.

We need to have a response from 50% of the owners (or 31 responses) to secure a quorum to complete our annual meeting voting.

Dusk to Dawn lighting
