HOA Insurance Renewal

One of the most important responsibilities of the Board of Division 7 is the annual renewal of the HOA insurance policy covering the portions of the buildings that HOA is charged with managing. Board Secretary Nancy Baer has handled this renewal review each year and is again working through the process.

RAT PROBLEMS REPORTED

There are a number of condo owners, not only in Division 7 but also in Division 17 North Sunland, reporting rats in their garage, walls, attics, and crawl spaces. The HOA of Division 7 is not responsible for eradication of these rodents – that responsibility falls on the condo owners. At times, these rodents will move to adjoining units through walls or small holes in crawl space shared walls.

Prevention suggestions from pest control providers include:

- Do not put out any food out for animals or birds. You are not only feeding birds or other animals, but you are feeding rats. Not only do rats feed on the birdseed, but they also FEED on small birds. According to Guy Richardson of Angeles Pest Control, their technicians found bird feathers and bird parts in rats nests in an attic recently!
- Notify other unit owners in your building that you have a problem so that they can also have their space checked!
- If you eat outside, clean up all trash and food carefully.
- Recognize that there will always be rodents to contend with in our environment and take the appropriate steps to mitigate their entry into your home by hiring a reputable Pest Control company to assess all aspects of your living space to advice you, especially if you see signs of rat or mice infestations. Only experts can assist you with effective prevention suggestions.

Remember – rats and mice can do significant damage to insulation and walls if not addressed, as well as posing a risk due to the bacteria they carry.

COVID Vaccine Update
